



FIREARM TRANSFER FEES & POLICY

There will be a \$40.00 Transfer NON-Refundable fee* charged for any firearm NOT purchased from current store inventory or ordered through Crossroads Shooting Sports.

The Fee will be collected prior to processing of the 4473.

N.I.C.S. SUBMISSION & DENIAL POLICY

(NATIONAL INSTANT CRIMINAL BACKGROUND CHECK SYSTEM)

Any Firearm received for transfer via an online purchase, or any other method, outside of an in-house order, is subject to these guidelines with respect to a N.I.C.S. check and possible F.B.I. denial of the transfer.

1. Upon a denial response from N.I.C.S. the original transferee will NOT receive the firearm. Since the BATFE and Federal Law prohibit “straw purchases”, there will be no local sale of the firearm(s) in question. The original transferee will NOT be able to have a family member or any acquaintance obtain the firearm for them.
2. Crossroads Shooting Sports will hold the firearm for a period of Three (3) months from the date of denial while the original transferee initiate the appeal process. Any extension of this time period will be at Crossroads Shooting Sports sole option. If during that 90 days, the final response is still a denial or the original transferee elects to NOT initiate the appeal process, the original transferee may elect to do one of the following options:
 - a. Exchange the firearm for either cash or in-store credit (at our option) towards any NON-firearm or ammunition purchase. This credit will be based on FAIR market value, as determined by Crossroads Shooting Sports.
 - b. Place the firearm on consignment here at Crossroads Shooting Sports with our “Consignment Agreement” in full force until sold with Crossroads Shooting Sports having full authority to negotiate a selling price.

- c. Place the firearm on an online auction site such as Gunbroker.com, with the customer covering all auction fees up front and all settlement fees to be deducted from auction proceeds, if the item sells. If this option is chosen it will be for One (1) auction period. Any re-listings will be at the option of Crossroads Shooting Sports and will have all additional fees covered in advance.
3. If upon a denial of the N.I.C.S. system, the original transferee decides to return the firearm to the original sender, all return shipping will be paid prior to sending. The return will be to the original shipping FFL ONLY. If the firearm is from an individual then the original transferee must make arrangements to have the firearm sent to an FFL of that state only. Crossroads Shooting Sports will NOT ship the firearm to an individual.
 4. Time is of the essence and failure to notify Crossroads Shooting Sports within a 10 day period, of your intention to follow one of the options stated above, will result in forfeiture of the firearm to Crossroads Shooting Sports with no further ownership of the item by the customer and no obligation for payment from Crossroads Shooting Sports.
